If two (2) or more persons conspire to prevent, by force, intimidation, or threat, any person from accepting or holding any office, trust, or place of confidence under the State of Mississippi, or any subdivision thereof, or from discharging any duties thereof, or to induce by like means any officer of the State of Mississippi or subdivision thereof, to leave the place where his duties as an officer are required to be performed, or to injure him in his person or property on account of his lawful discharge of the duties of his office, or while engaged in the lawful discharge thereof, or to injure his property so as to molest, interrupt, hinder, or impede him in the discharge of his official duties, each of such persons shall be fined upon conviction not more than one thousand dollars (\$1,000.00) or imprisoned for not more than five (6) years, or both.

Any person who shall enter any public place of business of any kind whatsoever, or upon the premises of such public place of business, or any other public place whatsoever, in the State of Mississippi, and while therein or thereon shall create a disturbance, or a breach of the peace, in any way whatsoever, including, but not restricted to, loud and offensive talk, the making of threats or attempting to intimidate, or any other conduct which causes a disturbance or breach of the peace or threatened breach of the peace, shall be guilty of a misdemeanor, and upon conviction thereof shall be fined not more than five hundred dollars (\$500.00) or imprisoned in jail not more than six (6) months, or both such fine and imprisonment.

On September 28, 2022, at approximately 1615 hours. I, Lt. David Mitchell, took a report at the Monroe County Shenff Office form Aberdeen Mayor Charles Scott

Mayor Scott stated on September 20, 2022, former alderman Nicholas Holliday entered city board meeting and was in the seat of the ward one alderman. He had placed his name plate in the place of the current alderman. Mayor Scott advised he confronted Mr. Holliday and advised him he wasn't allowed to be in the seat. He stated Mr. Holliday asked, "are you the mayor of Aberdeen and was he representing the city."

Mayor Scott advised he informed Mr. Holliday there was mandate form the Supreme Court where he had to wait 21 days. He sated that Mr. Holliday asked him if he superseding the Supreme Court. Mr. Scott stated at this point he asked for the sheriff department to Intervene.

He sated that Chief Shumpert asked Mr. Holilday to leave, and the alderwoman Lady B Garth tried to intervene, she told Chief Shumpert that Alderman Robert Devaull leave. He stated that when Deputy Randal arrived that Mr. Holiday finally went outside where he continued to video on face book live.

Mayor Scott advised that Lady B Garth came back to the meeting after previously leaving, walking around the table on both sides of the table like she was looking for something, making various comments, at one point she purposely bumped in the city attorney. She then left the meeting and returned a couple more times attempting to disrupt the meeting.
